L. Mrijaj

Mr. Astorino moved to receive and file the foregoing minutes and SEQR review, which were duly seconded and approved.

1. (51830) **CE/Human Resources** - Enter into a contract with the New York State Industries for the Disabled for Temporary Personnel Services for County Departments at various locations from 1/1/17 – 12/31/18, in an amount not to exceed \$500,000 per annum for a total aggregate not to exceed amount of \$1,000,000. Approval of Good Temps a division of GoodWill Industries of Greater NY & Northern NJ, Inc., NYC, as a subcontractor.

Mr. Astorino moved the resolution, which was duly seconded and unanimously approved.


