**Mr. Plunkett presided.**

**Mr. Plunkett said, "Good Morning and welcome to the July 14<sup>th</sup>, 2016 meeting of the Board of Acquisition and Contract. For the record, has the Secretary to the Board gone to the reception area to invite any members of the public who wish to attend today's meeting to come to this conference room?"**

**Mr. Plunkett continued, "Two things. One is next week we are meeting on the 21<sup>st</sup> and then we meet on the 28<sup>th</sup>. We meet on the first Thursday in August and then we take a two week hiatus and then we meet on the fourth week in August. I think that is the schedule for all of us. So let's see if our departments can get all their requests and resolutions in. I am going to ask our team to do that. Katy if you can watch over that."**

**Mr. Plunkett moved to receive and file the foregoing minutes and SEQR review, which were duly seconded and approved.**

1. (52140) **Social Services** – Amend a 10/16/13 Agreement with Westhab, Inc. to administer a Rental Assistance Program to assist up to 32 families, 33 single adults and 15 two-person households, from 9/1/13 – 8/31/18 in an amount not to exceed \$5,045,000, in order to reduce the term of the agreement by twenty months to a termination date of 12/31/16 and, effective as of 1/1/16, to reduce target population to be served to 20 working families who are over-income to receive Temporary Assistance benefits from the County, but cannot afford to pay rent with their own income; and 6 disabled and/or chronically homeless individuals; and 8 two-person families currently enrolled in the County Shelter System and to reduce the amount of the Agreement to an amount not to exceed \$2,732,150.


**Mr. Plunkett moved the resolution, which was duly seconded and unanimously approved.**

Statement of Michael B. Kaplowitz,  
Chairman of the Westchester County Board of Legislators

In 2011 the Westchester County Board of Legislators passed a local law that, among other things, made Board of Legislators' action sufficient to authorize the County Executive to implement Inter-Municipal Agreements – without approval of the Board of Acquisition and Contracts. The local law has subsequently been judicially sustained.

There is today a resolution before the Board of Acquisition and Contracts authorizing the County Executive to enter into Inter-Municipal Agreements.

I will vote for the resolution because I am in favor of the underlying matter. I recognize that the resolution is on the agenda pro forma.
