**Acquisition & Contract.** Minutes of the meeting 9/15/16 and the SEQR Review for agenda items.

**Mr. Astorino moved to receive and file the foregoing minutes and SEQR review, which were duly seconded and approved.**

1. (52663) **Board of Legislators** - Exercise its second and final one-year option under an agreement with O'Connor Davies, LLP, to which O'Connor Davies was to provide the Board with an analytical review of, and report on, the proposed County budget, from 11/1/14 – 10/31/16, by amending the agreement in order to 1) extend its term from 11/1/14 – 10/31/17, 2) increase the amount an additional \$146,000, for a new amount not to exceed \$429,000, to pay for services under the extended term, and 3) reflect the fact that the County will not have any options remaining and by reflecting the change in the name of the limited liability partnership from O'Connor Davies, LLP to PKF O'Connor Davies, LLPO.

2. (52668) **County Attorney** - Settle the lawsuit of Walter Slawinski v. The County of Westchester and Westchester County Department of Parks, Recreation and Conservation, by payment from the County of Westchester in the amount not to exceed \$67,500 of which \$10,313.36 will be paid to the Department of Veterans Affairs for medical care provided to plaintiff, Walter Slawinski, and the remaining \$57,186.64 paid to plaintiff.




**Mr. Astorino moved the resolution, which was duly seconded and unanimously approved.**
